By Nevada State law Sun City Summerlin Community Association, Inc., (SCSCAI) operates under the control and direction of an elected executive Board of Directors. This Board directs ALL the activities of our Association, including all of our community buildings, fitness centers, golf courses, restaurants, landscaping maintenance and so on. The responsibility is awesome and the compensation is \$0. So why do they do it? As a general rule the Board members are motivated by the desire to make Sun City Summerlin the best Association possible. I share that desire and work to make continuing improvements to our Association as directed by the Board.

In this issue of the Link, homeowners received a ballot for the election of a part of the Board. SCSCAI property owners will have the opportunity to select five Board members from a pool of nine candidates. In this issue of the Link you will find candidate bios with goals, desires and objectives of the candidates. I encourage you to exercise your right as an owner to vote for those candidates who will best represent your interests and the interests of the community in general.

When submitting your ballot, please review the ballot carefully and follow the directions so your vote will be counted. They also oversee the disposition and use of about \$15 million in capital reserves. It is, therefore, imperative that the owners select individuals for the Board who have the knowledge, skills and abilities to understand the complex operation of Sun City Summerlin. **Make sure you take the opportunity to study the issues and vote!**

SCSCAI ELECTION DAY, FEBRUARY 28

SCSCAI's Administrative offices at Mountain Shadows Community Center will be open for voting until 5 p.m. Tuesday, February 28. This is the last day to cast your ballot for the election for the Board of Directors. The staff will be available to supply replacement ballots and tend the ballot box. The ballots will be secured in the Association Office until the following day. The ballots will be validated, opened and counted starting at 8 a.m. on Wednesday, March 1, during an **OFFICIAL ASSOCIATION MEETING - OPEN TO ALL RESIDENTS**. There is only one agenda item for this meeting, that being the counting of the election ballots. The results will be announced by the Association Secretary and reported to the Board of Directors.

Sun City's Articles of Incorporation

A vote to change from NRS 81 to NRS 82 would eliminate the revenue tax

(Editor's note: This column is republished from the President's Message that appeared in the November 2016 Link. The information regards the upcoming vote by Sun City unit holders on a proposed plan to change the Association's Articles of Incorporation.)

On June 22, 1989, Del Webb filed Articles of Incorporation to establish Sun City Summerlin Community Association, Inc. The document was created and filed under the laws of Article 81 of the Nevada Revised Statutes.

Article 81 is a concise, 15-page document that specifies that the master Association will cease to exist in 50 years, or on June 22, 2039. We are, therefore, just 22 years away from your Association ceasing to exist.

Currently, SCSCAI is required to pay the new revenue tax to the state of Nevada under Article 81 in an approximate amount of \$16,000 annually.

What can we do to eliminate this issue? Fifty percent of unit owners, plus one, can vote to change SCSCAI's Articles of Incorporation from NRS 81 to NRS 82. Should unit owners elect to change to Article 82, the revenue tax

would be eliminated.

Your Board of Directors has asked our legal counsel to explore a change to Article 82, and the Board approved the concept. The plan will be presented to unit owners for a vote after March 1, 2017.

Voting in favor of this change will do two things for our community:

1. Eliminate the revenue tax that we now pay under Article 81.
2. Create a corporation under Article 82 that will survive in perpetuity. The date of dissolution of our corporation on June 22, 2039, will be eliminated.

Please be aware that this issue will come before each of the unit owners in 2017. Details will be made available in the Link. This matter is of extreme importance to you, and your Board of Directors intends to keep you informed until the vote is taken.

His favorite past times include board games around the dinner table, playing sports, traveling and watching movies with a family-sized bowl of caramel popcorn.

Sun City Summerlin Community Association, Inc., was established in 1989 and people from all walks of life with wide-ranging interests soon began starting new chartered clubs of all kinds. Melissa also represents the Community Services Department by attending other monthly committee meetings.

Melissa is the club coordinator and liaison to the Clubs and Community Organizations Committee (CCOC), a standing committee of the SCSCAI Board of Directors. CCOC is composed of one member of the SCSCAI Board and several dedicated resident volunteers who make recommendations regarding policy and arbitrate matters of conflict that may occur within the chartered clubs and community organizations. CCOC provides direction and structure and, yes, a few necessary rules that enable all residents to enjoy our facilities and the recreational activities offered by our chartered clubs.

The Community Services office, located at the Desert Vista Community Center, is also responsible for community events such as the annual Home Expo and Arts & Crafts Fair, as well as monthly bus trips to various locales in Las Vegas and beyond. Melissa's administrative assistant and Sun City resident **Janine Lowen** assists with the research and planning for these events. An 11-year staff member, Janine is usually the first face you will see at the front desk. She assists with all club-related matters, correspondence, annual club forms, creates the advertising and fliers for many events published in the Link magazine, and various other behind-the-scenes duties.

Mary LeBaron, also a Sun City resident, and a one-year staff member, is the scheduling coordinator. Mary is responsible for booking the vast number of chartered club meetings, resident and non-resident birthday and anniversary parties, religious services, memorials, picnics and outside businesses needing space in Sun City to hold their events in the four community centers.

The 27 social monitors working at Desert Vista, Mountain Shadows and Pinnacle are also a part of the Community Services team. They provide general information about Sun City and events, check out equipment for residents' use, provide tickets to fitness seminars, sell tickets for our theater performances and trips, monitor the use of our facilities and make sure that each facility is safe and comfortable, and used exclusively by our residents and their guests.

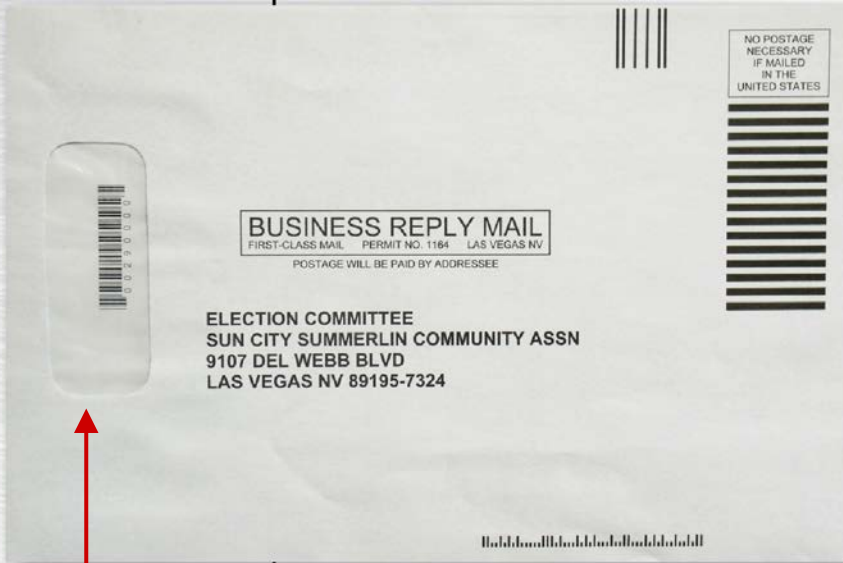

The four candidates with the highest votes will be elected for two-year terms; the fifth successful candidate will serve a one-year term. (Reference Bylaw Art. 5.3(b)).

address. Insert the ballot half into the envelope so that the "Bar Code," which is used for validation, shows through the envelope's window. On vote-counting day, the Election Committee will cut off the Bar Code before removing your secret ballot. We will use optical scanners to count the ballots and tabulate the votes electronically.



PLEASE MAKE SURE THE BAR CODE SHOWS THROUGH THE ENVELOPE WINDOW.

2. **The ballot is the address label for the February Link and a pre-posted return envelope is included with the magazine this month.** Instructions are printed on the ballot. A household has 5 votes.
3. **After marking the ballot, remove the "Instructions" side to remove your name and**

4. **If you make a mistake marking your ballot, DO NOT correct it. Instead, exchange the old ballot for a new one at the Administration Office at Mountain Shadows.** Each member household will receive one ballot and will have five (5) votes. Before requesting a replacement ballot and envelope, be certain that another member of the household has not voted. Should two ballots be received from the same home, **BOTH ARE VOID.** Casting **MORE THAN FIVE VOTES** also will **VOID** the ballot. Your votes may be cast for one candidate or divided among two or more candidates.

5. **Validation and counting of the ballots occurs at an official SCSCAI Association meeting on Wednesday, March 1, starting at 8 a.m. at Mountain Shadows.** The election results will then be announced by the secretary of the Association. All those who wish to witness the ballot tabulation are invited to attend the ballot counting meeting.

PURSUANT TO NRS 116.31034, SECTION 12

An association shall not adopt any rule or regulation that has the effect of prohibiting or unreasonably interfering with a candidate in his campaign for election as a member of the executive board, except that his campaign may be limited to 90 days before the date that ballots are required to be returned to the association. A candidate may request that the secretary or other officer specified in the bylaws of the association send, 30 days before the date of the election and at the association's expense, to the mailing address of each unit within the common-interest community or to any other mailing address designated in writing by the unit's owner a candidate informational statement. The candidate information statement: (a) must be no longer than a single, typed page; (b) must not contain any defamatory, libelous or profane information; and (c) may be sent with the secret ballot mailed pursuant to subsection 8 or in a separate mailing. The association and its directors, officers, employees and agents are immune from criminal or civil liability for any act or omission which arises out of the publication or disclosure of any information related to any person and which occurs in the course of carrying out any duties required pursuant to this subsection.

Successfully Starting a Neighborhood Watch

Neighbors agree to watch out for each other, talk with each other and say something if anything unusual is seen

Neighborhood Watch groups within Sun City Summerlin have multiplied over the past year. One very successful group consists of more than 42 residents who have a common street name. They have shared their simple and direct recipe for starting a successful group:

Neighborhood Watch (Watch) is a simple idea: Neighbors agree to watch out for each other, talk with each other and say something if anything unusual is seen.

There are a lot of people willing to help you start a Watch. We suggest that anyone interested in forming a Neighborhood Watch attend a First Tuesday meeting at our local Las Vegas Metropolitan Police Department Northwest Area Command post (9850 W. Cheyenne Ave.) You will hear others discuss crime reduction efforts in neighborhoods around Sun City. You

will have a chance to meet and talk with Kathy Cassell, who coordinates the efforts of more than 50 Watches in our area.

Starting Up

We, the captains, walked up and down our street, leaving fliers that invited residents to an informal meeting that would be hosted in 10 days. We used the most obnoxious colors we could in the flier and posted it on front doors. Our aim was to make the

invitation hard to miss. The meeting location was the front patio of a house in the middle of the block.

The primary spokesperson for the meeting was Kathy Cassell. We had established earlier when she could come to help start our group. The meeting's date and time were defined by her schedule. She did a great job explaining what a Watch did and just as importantly what a Watch doesn't do. She introduced us to a number of ser-

vices and documents available through Metro to help support our group. However, in our opinion, the true significance of the meeting was the collection of people on the patio.

Historically, one would predict the response to our invitation to be around 15-17 percent of those on our street. We did the math and predicted around 10 would show up. Nineteen neighbors walked over for the meeting. This was nearly 30 percent of our street! This was a clear message to us that there was strong interest in supporting a Watch.

The meeting was the first time many of us had a chance to introduce ourselves to our neighbors. All we asked was that those at the meeting sign a sheet to share their names, addresses, phone numbers and e-mail addresses. Our promise as co-captains was to communicate often. At a minimum we send out a short monthly newsletter. We pass along any information released by Metro, as well as any lessons learned by other Watches.

Watch residents receive our newsletters as e-mail; those without computers get a hard copy delivered, and phone calls are made when needed. Informal, face-to-face discussions provide the glue that holds our group together.

Communication Ensures Success

To ensure we continue to be a credible group the Watch captains monitor e-mail on a daily basis. If a question or concern is raised we know we need to respond as quickly as possible. We continuously review and share recommendations provided by Metro or Sun City Security Patrol. We provide recognition to members who further strengthen our Watch efforts. When Sun City started its K-9 Corps, one resident and his constant canine companion were among the first to volunteer and earn the red dog bone tag.

As block captains we know we must always be approachable and willing to talk with residents to maintain the trust of our Neighborhood Watch group.

What's Happening in the Properties Committee?

I am highlighting from the minutes of our last meeting in December what I think residents would want to know. And I would like to point out the good news that between the \$20,000 saved in using LED lights on the sports courts, and the LED lights we used for Christmas lighting, the overall savings to our community will be approximately \$80,000! I think I speak for our entire community in giving thanks to all those committee members and our Association staff that made that happen.

Here are the highlights:

Louis Darling, landscape manager:

- ♦ A design has been approved by the Architectural Review Committee and he will start on the Rampart Boulevard entrance soon.
- ♦ He will be meeting with the Las Vegas Valley Water District at greenbelt No. 2, Willow Park, for turf reduction and also at the Lake Mead Boulevard entrance, on both sides.
- ♦ The Mountain Shadows pool area is in the process of being redesigned with some pine trees taken out and a shade structure being built by the pool. By the next meeting, Louis will have a design done for that area.

Brian Bagwell, golf course maintenance general manager:

- ♦ Sand is still being delivered for the bunkers at Palm Valley.

Kristie McWhorter, SCSCAI fitness manager:

- ♦ A NuStep was replaced at Desert Vista, which is a higher-end model that the residents love.
- ♦ Kristie showed samples for replacement of the carpet at the Mountain Shadows Fitness Center. After considerable discussion, the committee recommended that Kristie return to the next meeting with rubber tiles and more colors to choose from.

Brandon Balek, building maintenance super:

- ♦ LED lights were used for the holiday lighting.
- ♦ The rebate was approximately \$20,000 from the LED lighting at the sports courts, and the savings in all should be about \$80,000 a year in energy costs.

- ♦ The fencing at the Mountain Shadows horse-shoe pits was finished and the tarps will be installed next.
- ♦ As soon as NV Energy starts up its rebate program, LED lights for indoor lighting at Mountain Shadows' three buildings will be ordered.
- ♦ The Eagle Crest tunnel lighting had to be re-routed and the lights are now back on.

Unfinished Business:

- ♦ Fred Baniecki gave a summary of why artificial turf is needed for the baseball field.
- ♦ Mike McComb, a local vendor, gave a presentation on the turf and what the cost and upkeep would be.
- ♦ A motion to recommend to the Board of Directors the process of adding artificial turf to the infield of the ball park. The motion was seconded and passed with one opposed.

New Business:

- ♦ Jim Akers presented the committee with plans to build a shade structure at the Mountain Shadows' pool and remove pine trees that are shedding pine needles into the pool.
- ♦ Brandon passed out a quote to build the structure on one side of the pool. The structure would be similar to the one built at the Pinnacle pool and pavers would be put down on the deck area.
- ♦ A motion was made to recommend to the Board of Directors to build the structure not to exceed \$30,000. The motion was seconded and passed unanimously.

Team Leader Reports:

- ♦ Amos Barcus reported that all issues were taken care of at Mountain Shadows.
- ♦ Rhoda Ring asked about Desert Vista ball-room chairs, as she needs to order samples. She would also like to get started at The Summit.
- ♦ Murray Waks reported that everything at the Pinnacle has been taken care of.
- ♦ Fred Kaufman reported for Sherry that they haven't inspected Sun Shadows because of the work going on.

DEEP: Diabetes Empowerment Education Program

One in three adults will develop Type 2 diabetes in their lifetime; and 9 out of 10 of them don't even know they have it

Did you know that diabetes leads a disease list of health care spending in the United States with \$245 billion? And that one in three adults will develop Type 2 diabetes in their lifetime; and 9 out of 10 of them don't even know they have it (www.diabetes.org)? Diabetes is a problem with your body that causes blood glucose (sugar) levels to rise higher than normal. In Type 2 diabetes your body does not use insulin properly, called insulin resistance. Management of blood glucose levels is critical for those with diabetes as they will become susceptible to other health problems associated with diabetes.

Health professionals believe that the more you know about Type 2 diabetes, the better able you are at making lifestyle changes and decisions that will improve your health. That's why we are offering our Diabetes Empowerment Education Program (DEEP). Taking an active role in your health is a step toward a healthier and happier life.

DEEP is for those living with and supporting people with diabetes who need information on how to better manage the condition. The program helps those with diabetes to improve and maintain their quality of life, prevent complications and disabilities, improve eating habits, maintain adequate nutrition, increase physical activity, develop self-care skills, improve patient and health care team relations, and increase the use of available resources.

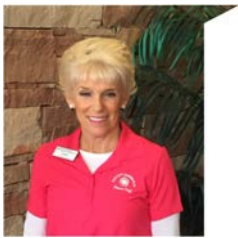

Are You Seeing Results With Your Treadmill Workout?

Here are some common mistakes that could be hindering you from getting the results you want and need from your

treadmill or cardio training.

1. **Skipping warmup:** Easing yourself into your workout is a great way to prevent pain and avoid injuries.
2. **Reading while walking:** Are you breaking a sweat during your cardio? Are you seeing any results? If not, you may want to put down your magazine, book or tablet and push yourself by changing the speed or incline.
3. **Holding onto the side rails:** If you have to hold on to walk at a faster pace you probably aren't doing yourself any good. When you hold on you are actually supporting your upper body and core and ultimately making it easier for yourself. Instead, slow your pace and pretend the rails are not even there.

4. **Sticking to one speed the whole time:** Your body is the great adapter! When you do something over and over again it gets easier and your body doesn't burn as many calories. Varying your speed or incline is a great way to get your body to burn more calories and make your heart stronger.

If you would like to add some variety to your treadmill work out, you can sign up for an orientation with one of our fitness specialists. Just ask your friendly Fitness Monitor to put you on the schedule. We have day and evenings times available.

Dispatchers Keep the Communication Flowing

To keep Sun City Summerlin one of the safest communities in Las Vegas, your Security Patrol is on duty 24 hours, 365 days every year since its inception in 1992. Not a bad record considering that the Patrol is a volunteer service organization made up of your neighbors.

One of the positions vital to its work is dispatch. In future months, this page will explore other positions equally as important to keeping us all safe.

returned to the Administration office or Security base.

Maintaining regular radio contact with the drivers patrolling the neighborhoods is crucial to the Patrol volunteer's safety. Dispatchers also maintain contact with volunteers at the information centers on Lake Mead, Del Webb and Sun City boulevards. These volunteers are the first contact visitors have with our community, providing general information and maps of Sun City.

Dispatchers are communications central. Women and men, who for four hours, answer phone calls from neighbors about lost pets, suspicious situations, worried adult children who haven't heard from their parents and worried neighbors who haven't seen their neighbor in a few days. Then, of course, there are the open garage doors during the evening hours. As you probably know, an open garage door is an invitation to thieves. If a Patrol driver is unable to talk with the home owner whose garage door is discovered open, it becomes the dispatcher's job to phone the resident. If unsuccessful, the dispatcher will call the designated person on the emergency contact form you filled out when you moved into the community and

Dispatchers train first at the initial meeting where they learn about the Patrol and the regulations we must follow. Next comes on-the-job training on each of the four-hour shifts. This is followed by four solo shifts. At each step, there is a dispatch trainer to guide and help the trainee (even on the solo shifts if requested). No prior experience is necessary. Residency or home ownership in Sun City Summerlin is the only requirement.

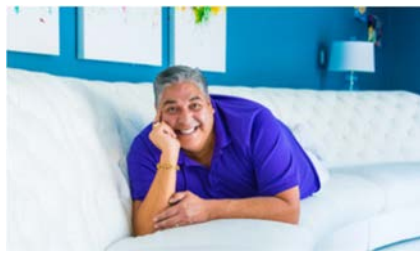

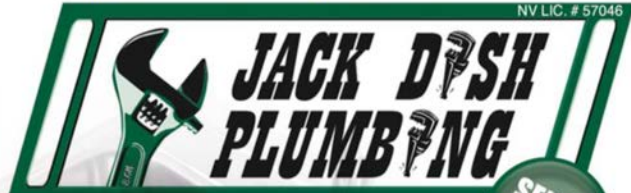

Also note that volunteers cannot prepare state returns, rental property deductions, business or partnership (K-1) income other than simple interest, dividends or capital gains. Questions? 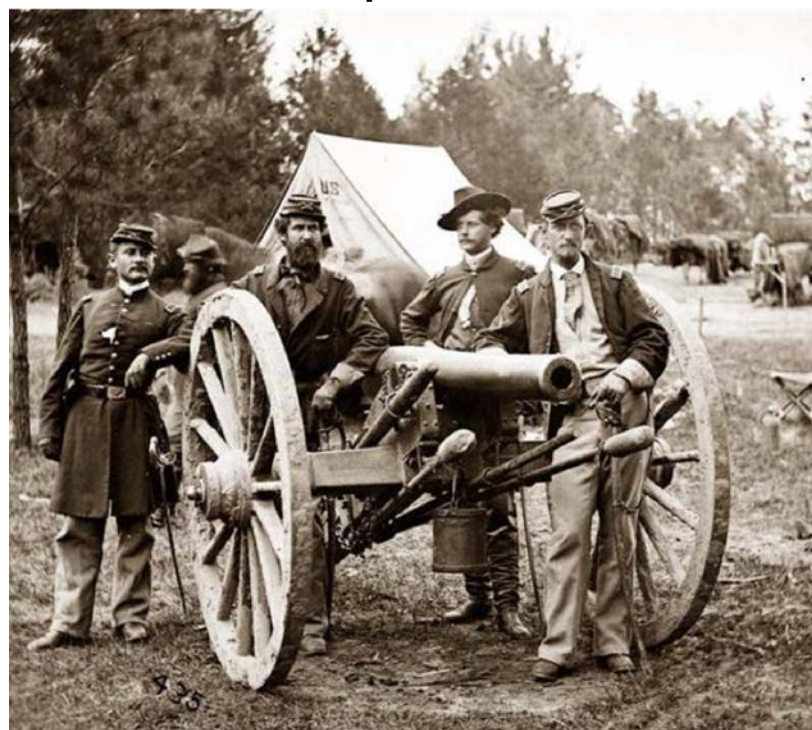

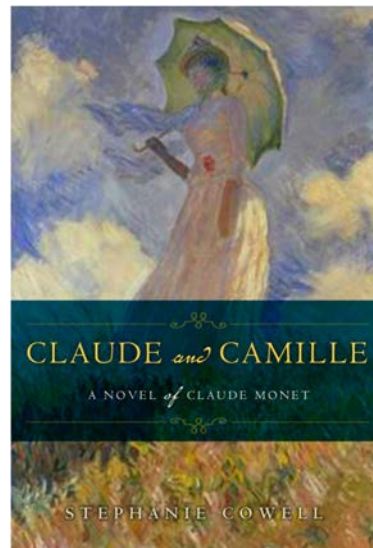

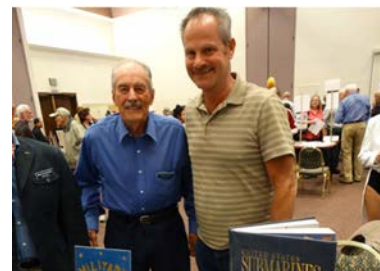
