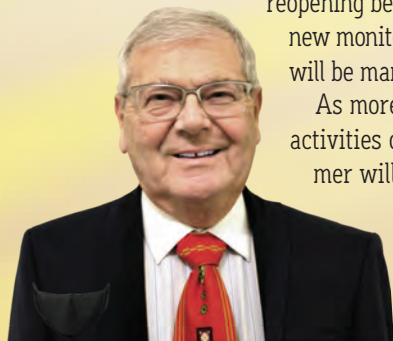

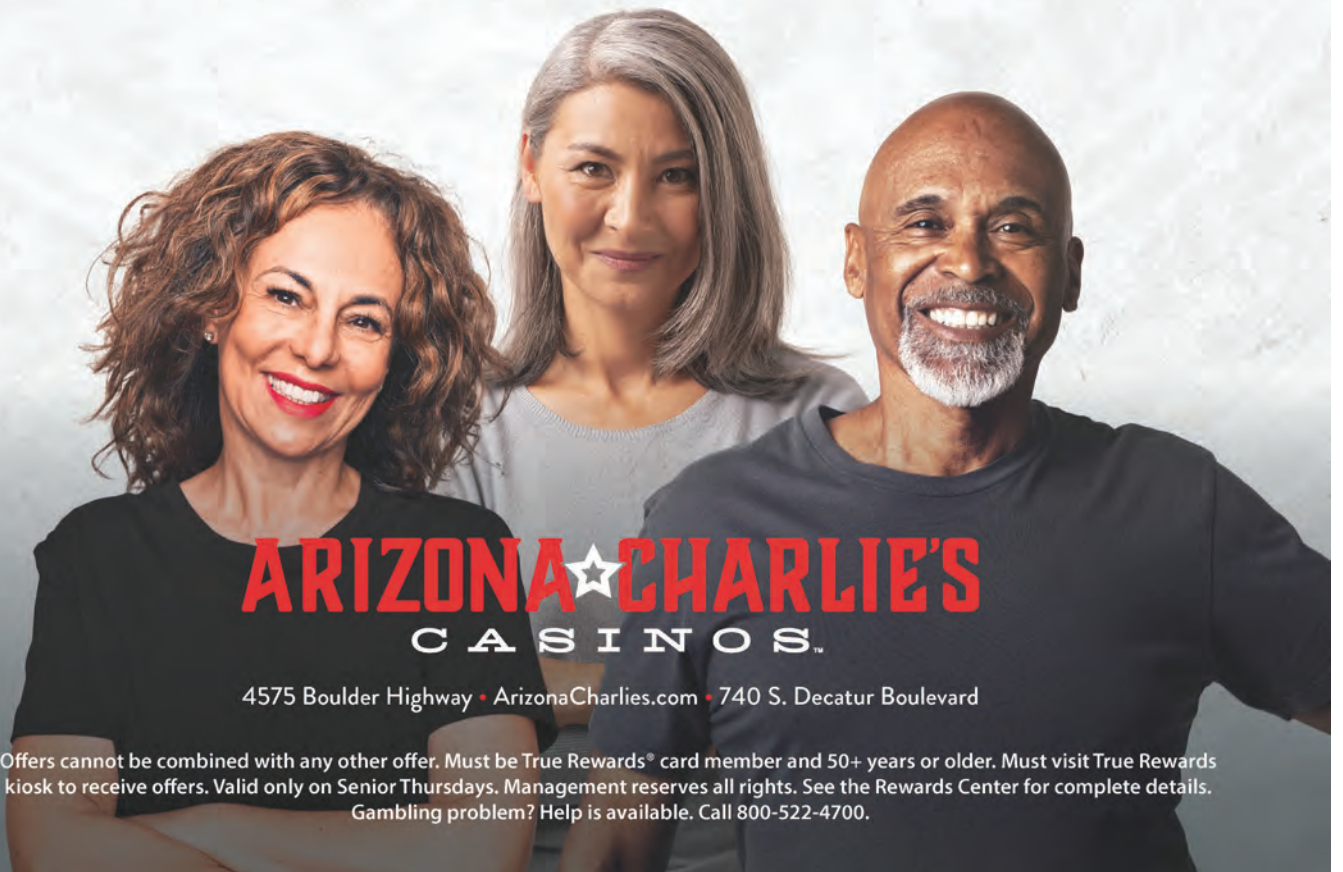

"I cannot think of any need in childhood as strong as the need for a father's protection." - Sigmund Freud.

Although there are more than 70 million fathers in the United States, Father's Day doesn't seem to get as much attention as its Mother's Day counterpart. Why is that? There appear to be several reasons that contribute to the answer.

First, although Mother's Day was declared a national holiday in 1914, Father's Day wasn't nationally recognized until 58 years later in 1972. Presidents Woodrow Wilson, Calvin Coolidge, and Lyndon B. Johnson, all supported the holiday, but it wasn't until Congress finally passed a resolution which President Richard Nixon signed two years later, that Father's Day became official. Celebrated on the third Sunday of the month; this year, Father's Day will fall on Sunday, June 20, 2021.

Another reason, as one historian wrote, "Men scoffed at the holiday's sentimental attempts to domesticate manliness with flowers and gift-giving, or they derided the proliferation of such holidays as a commercial gimmick to sell more products – often paid for by the father himself."

The holiday appears to have originated in a West Virginia church on July 5, 1908, when the church sponsored an event to specifically honor fathers. This one-time event was held to honor the 362 men who lost their

lives in an explosion at the Fairmont Coal Company mines in Monogah.

The following year, Sonora Smart Dodd, a woman from Spokane, Washington, one of six children raised by a widower, successfully established a holiday for fathers, and Washington State celebrated the nation's first statewide Father's Day on June 19, 1910.

The holiday slowly spread over time. In 1916, President Wilson honored the day by using telegraph signals to unfurl a flag in Spokane, by pressing a button in Washington, DC. In 1924, President Calvin Coolidge urged states to observe Father's Day.

In other countries, particularly in Europe and Latin America, fathers are honored on March 19, St. Joseph's Day, a traditional Catholic holiday.

The father in the family is an important and significant contribution to a child's wellbeing. Studies show that for both male and female children, the father serves as the first blueprint of what a man's role should look like. A good father figure can significantly impact his children in helping them make positive relational choices in their development toward adulthood.

The role of Dad has since shifted from when Father's Day was first conceived. For many years, fathers were considered the protector and breadwinner of the family; mothers were in charge of the children and the household. Today, most fathers are no longer the single breadwinner in the family and have become more involved in family life.

While holiday spending for dads is currently about half of what is spent for Mother's Day, as fathers' roles continue to change to stay-at-home dads, single dads or as partners both contributing to the financial support of the household, many believe that Father's Day will become more popular as time goes on.

As President Lyndon B. Johnson wrote, "If the father's responsibilities are many, his rewards are also great – the love, appreciation, and respect of children and spouse."

Happy Father's Day!

YEP, I'M A Daddy's Girl

It's not a matter of age; it's a feeling that can last forever. My first memory of being a "Daddy's Girl" was on the Steel Pier in Atlantic City, when my father reached to take my hand and lead me onto the dance floor, dressed in my laced socks, patent leather shoes, and crinoline dress. I was truly a five-year-old princess. Sadly, the day came when it converted to being raised by a single father; in those days, mothers just did not "leave", but mine did.

My dad somehow managed to raise two little girls, aged eight and eleven, and learned the hard way. He could soon pack lunches without having them leak through the paper bag; through trial and error, how to sort clothes so as not to turn everything pink; he coped with the nuns when we got into trouble. My dad was there when I "flew up" from Brownies to Girl Scouts and often bought all my cookies to take to work! He suffered through my attempts in the kitchen and taught me how to do so many things around the house, I would have made someone a good husband!

He had a very kind heart, even though he could swear like a longshoreman – no more evident than when he taught me how to drive his Chevy Impala! Yet, every morning I saw him through the crack in the bedroom

door on his knees, saying the rosary, praying to be the best father he could be. And he succeeded. He was the one who changed my bandages for months after my surgery; he cried when he opened the Christmas present with the photographs my sister and I had done. I can still hear him beautifully whistling "Whispering" or "Peg O' My Heart", and how much he sounded like an air-raid siren when he whistled with his fingers for us to come from playing in the evening.

Every neighbor within blocks called on him for help, as did my friends growing up. So many of them would stop just to have coffee or a soda and talk with "Pap", as they all called him – it mattered not if I was home because "Pap" was always there to listen to the trials and tribulations of a teenager. He suffered

through noisy pajama parties, killing spiders when we screamed, and lived long enough to walk me down the aisle.

With two parents, raising kids is often a divided job, but my dad did it all, and there are single fathers out there doing it all now, due to any number of reasons. Being a "Daddy's Girl" is something I always claimed and still do to this day even though he has been gone for a very long time. I often reflect on my dad raising two girls on his own and how it was anything but normal back then. He was tough when he needed to be, and warm and loving as the only parent filling in for two. I'm sure I suffer from selective memory – but that's my prerogative!

So often Mother's Day is celebrated in a grand manner in every aspect, and Father's Day, well he may get a nice card (in my day, it was a card and a tie). In today's world, with both parents working, fathers often take over some of the duties normally done by a mom but growing up for me, made me the odd kid in school when everyone else had a Mom. So, to all of the fathers out there, no matter your age or your daughters' – and especially to any single fathers from a "Daddy's Girl" – Thank you, Dad – it's the best title I ever had!

The Choice is Yours

Sun City Summerlin Security Patrol is comprised of an all-volunteer working group of residents. Patrol members have spent hours of classroom and on-the-job training to help support their neighborhood in many different capacities. From checking the security of association buildings outside of normal working hours, to being an important set of eyes and ears on Sun City streets round the clock. The patrol, however, does not perform any function normally reserved for law enforcement officers, nor do they enforce any S.C.S.C.A.I. rules and regulations.

To delineate further, those actions which are the sole responsibility of the Las Vegas Metropolitan Police Department law enforcement in Sun City, there follows a discussion of some of the key areas. We spoke with Randy Klenosky, the Summerlin Area Command Crime Prevention Specialist, and is very active with the Neighborhood Watch program and experienced in all aspects of law enforcement. He was joined by Brian Leahy, also stationed at Summerlin as Community Oriented Policing Coordinator. So often, citizens look to police as enforcers of laws. After spending time with these gentlemen, it was exciting to feel their genuine desire to keep folks safe. This is the one constant when explaining many of the "rules of the road" and in our everyday lives.

"What entity "owns" and governs the streets in Sun City?"

"The streets in Sun City are the responsibility of the City of Las Vegas. The Police Department prefers to help residents safely use the streets as either motorists or pedestrians." Randy and Brian both pointed out they would rather educate than penalize, but all traffic laws apply.

"What would you suggest to folks as they head out onto the public streets?"

"Drivers should be proactive; they should be observant, not be distracted and follow the speed limits. There are many reminders along Sun City streets to check your speed, even one with a digital record of exactly how fast you are going. Drivers should always be aware of pedestrians!"

"Define a proper "STOP"!"

"If there is a white line, the stop must happen before the solid white line. If there is

no white line, the stop must happen before reaching past the curb line. Wheels must come to a complete stop. All of the car's weight should now be on the rear section of the car." Interesting concept.

"Can folks be ticketed for parking partway on a sidewalk?"

"You could be, but it is better you understand why it is so important to keep the sidewalks clear for pedestrians to use. We have folks with walkers, canes, wheelchairs, etc., who count on clear passage as they move around Sun City."

"What can you say to folks walking in the street right of way?"

"There is a big increase in pedestrian versus automobile accidents. Our police friends implore that it is in your best interest to use the sidewalks whenever possible. Only cross streets at a designated crosswalk or corner. Please do not step into the street until you are sure all drivers have stopped, are not distracted, and know you are on the move. Best practice is to wait until there are no drivers in the area."

"Sun City is a golf cart allowed community. What does this mean for residents and others using golf carts as transportation on the streets in Sun City?"

"Every driver of a golf cart using city streets in a permissible community must hold a current drivers' license. They should carry their license with them. Golf carts in some communities may be required to have a permit, or decals, depending on the time of day. Sun City administration states that those are not necessary in our area, but all should carry insurance. Drivers of golf carts must follow all traffic laws and speed limits."

"This isn't about traffic laws, but could you discuss the importance of keeping garage doors secured?"

"When garage doors are left open and no one is visible, it is what is called "a crime of opportunity." Once a person gets into a garage, the door can be closed, and the "bad person" has free rein."

"Are there any other points you'd like to make for the residents of Sun City?"

Randy and Brian discussed the phone numbers for calling the police. "Of course, 911 is the emergency that is familiar to us. 311 is the non-emergency number, and those callers will find themselves on hold many times as police assets may be stretched thin. These calls will be answered in order. One other point, if you are the victim of a crime, please do not disturb the scene until the police have arrived and can assess the situation."

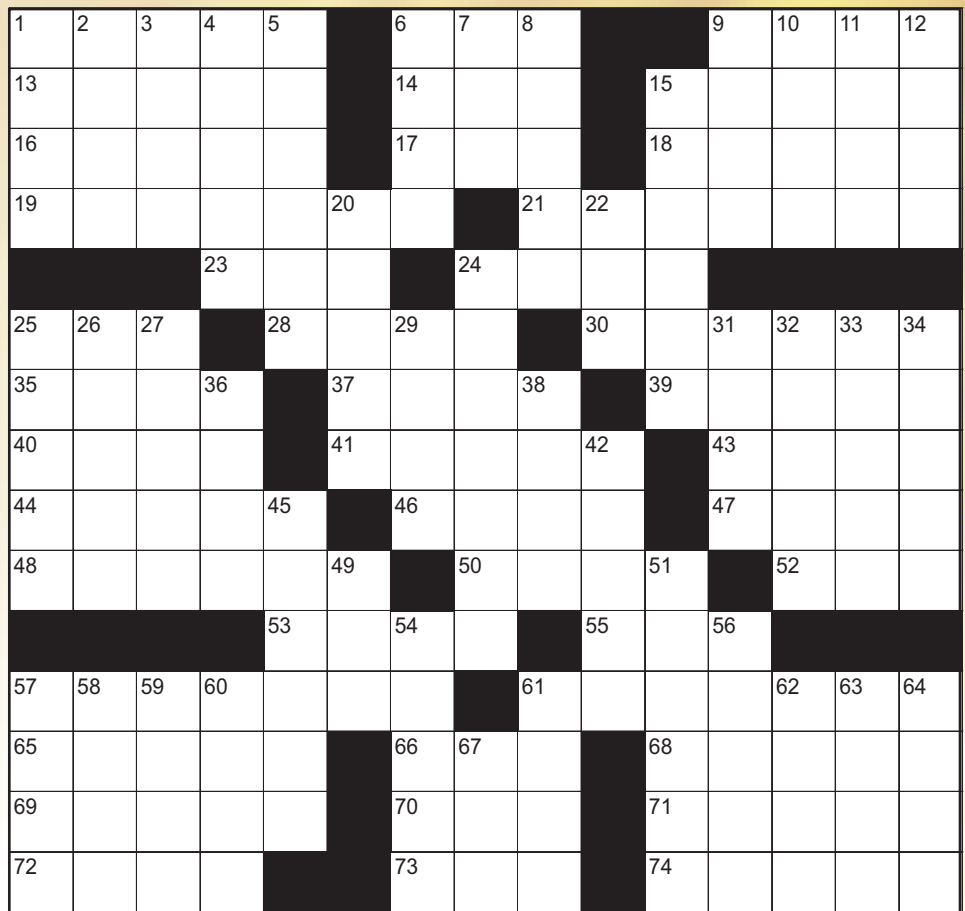

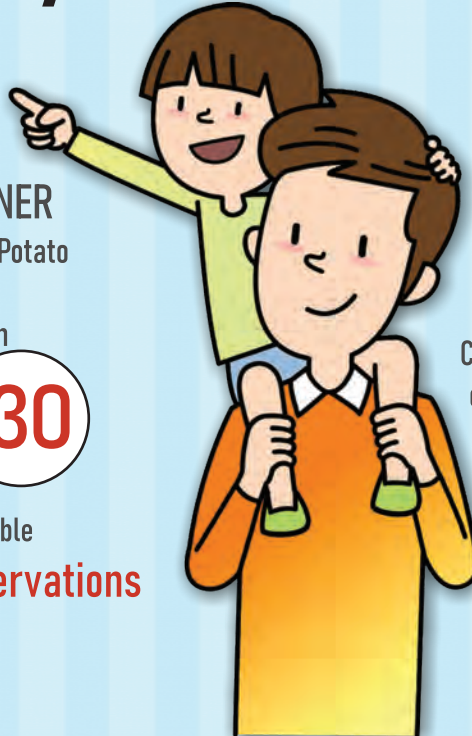

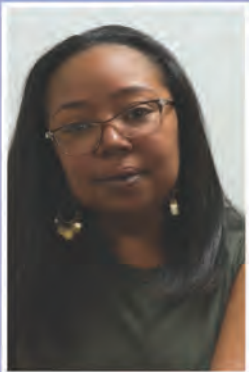

As an example, in the past few months, we have seen a number of people moving from our Sit 'n Fit class to the more strenuous Sun City Strength class. We have also heard success stories, within our community, of people that have come out of the pandemic in BETTER shape than before. Kudos to them!

Many of us 65 and older, tend to focus on cardio as our main form of exercise. While there are numerous benefits to cardiovascular fitness, it is highly recommended that strength training be incorporated into your workout regimen. In the past two months, we have discussed the many benefits of strength training for seniors; increased bone density, increased muscle strength, better balance, etc.

When it comes to seniors and strength training, we often get asked the question "Is it safe?" Most understand that strength training in general is safe but believe that heavy-lifting or high-intensity strength training is not. They could not be more wrong. You may need to modify some of your exercises, but the overall principles of high-intensity strength training are the same for young and old.

High-intensity strength training may bring about visions of large, muscle-bound men in tights lifting huge barbells or female bodybuilders that are extremely "bulked-up."

If you are a woman considering strength training, getting "bulked up" is something you can take off your list of things to be concerned about. Most women cannot achieve that look naturally and when they can, it takes a lot of work, a special diet, and usually supplements.

Are there risks? Yes, as there are with taking on any new physical activity; but the benefits far outweigh the risks. This type of training can be very safe if you follow a few guidelines:

See your doctor first. Get clearance from your medical practitioner and possibly a physical therapist if you are new to strength training.

Employ good technique. Good exercise technique is critical for efficacy as well as reducing the chance of injury. Consider working with a personal trainer for tips and or training on good technique for your workout.

Start lighter and work your way up. If you are new to strength training, you may need to start with a lower-intensity program.

Continue to progress. There will come a time when your exercises are no longer challenging you. When you reach that point, you want to avoid a plateau. You can increase your weight, include more challenging exercises, different equipment, or increase the duration. Keep challenging your muscles. This is what makes them stronger.

Always warm-up and stretch. Warming up is especially important if you are doing high-intensity strength training. It helps prepare your body for the workout by lubricating the joints and improving your range of motion, thereby decreasing the chances of injury. In your attempt to progress, make sure you do not over-exercise or increase the weight too much at a given time. Stretching afterwards can reduce post-workout stiffness and soreness.

Complement your strength training with proper nutrition and adequate rest. Eating well and getting a good night's sleep helps your body repair itself. Honor your body's rate of progress and ensure you give your muscles rest in between workouts. At least one day between strength sessions is recommended.

Following the above guidelines will greatly increase your chances for success with strength training. You are NOT too old to start!

Nutrition to Strengthen Muscles and Bones

Calcium, vitamin C, and vitamin K are important for bone health throughout our lives. Healthy Cranberry Broccoli Salad, a perfect summer side dish contributed by Sun City Summerlin resident Mary Fairhurst, who has a passion for healthy cooking and education. Mary stays strong with strength training six times a week and has been a Fitness Committee member for over two years.

Let's take a look at the recipe's ingredients:

According to the United States Department of Agriculture (USDA), a cup of broccoli weighing around 76 (g) contains 3% to 3.5% of a person's daily need for calcium, 45-54% of their daily need for vitamin C, and 64-86% of their daily need for vitamin K, depending on their age and sex.

Chickpeas: Good source of calcium and iron. Chickpeas can play a role in preventing osteoporosis.

Pecans/Walnuts: Pecans are a good source of phosphorus and calcium. They also contain vitamins E and C, as well as a variety of antioxidants that help protect your bones from oxidative damage. Walnuts contain a high amount of manganese. Manganese has been shown to prevent osteoporosis in combination with the minerals calcium and copper.

Red Onion: Studies have found that consuming onions on a regular basis improved bone mineral density and decreased the risk of hip fractures.

Apples: Eating fruit is linked to higher bone density.

Cashews: Cashews contain magnesium and in combination with calcium has been shown to prevent osteoporosis.

Cranberry Broccoli Salad with Oil-Free Creamy Dressing



Prep: 20 min **Total:** 20 min **Servings:** 6 Servings

For the Salad

- 6 cups broccoli florets cut into small bite-sized pieces
- 1-15 oz. can chickpeas drained & rinsed
- 1/2 cup pecans or walnuts
- 1/2 cup dried unsweetened cranberries
- 1/4 cup red onion finely chopped
- 2 green apples chopped
- 1 tbsp. lemon juice

For the Dressing

- 3/4 cup raw cashews*
- 3/4 cup water
- 3 tbsp. lemon juice or apple cider vinegar
- 4 tbsp. pure maple syrup (not pancake syrup)
- 1/4 tsp. sea salt

Instructions

Dice your apple and place in a large bowl. Then squeeze 1 tbsp. of fresh lemon juice on top to prevent the apples from browning and mix well. Add all remaining salad ingredients to the same bowl and mix together.

Add all the dressing ingredients to your blender and process until smooth. Pour the dressing over the salad, mix well, and refrigerate for four hours or longer, before serving. It is best to refrigerate overnight.

*If you do not have a powerful blender, like a Vitamix, first soak your cashews overnight or in boiling hot water for at least 30 minutes, and then drain before blending. This will help soften your cashews enough to blend smooth.

You'll notice that the recipe calls for lemon juice twice. The first is to prevent the apples from turning brown, as well as flavor. The second is for the salad dressing. Both are needed.

Use a tart apple, like granny smith for the best tangy flavor.

Some thoughts on friendships –

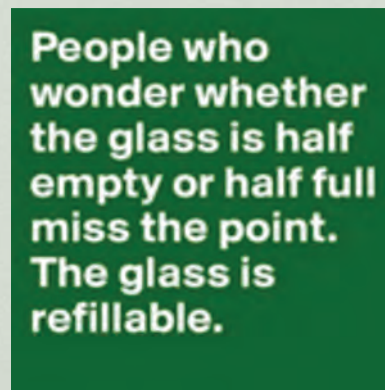
"To have a friend, be a friend."

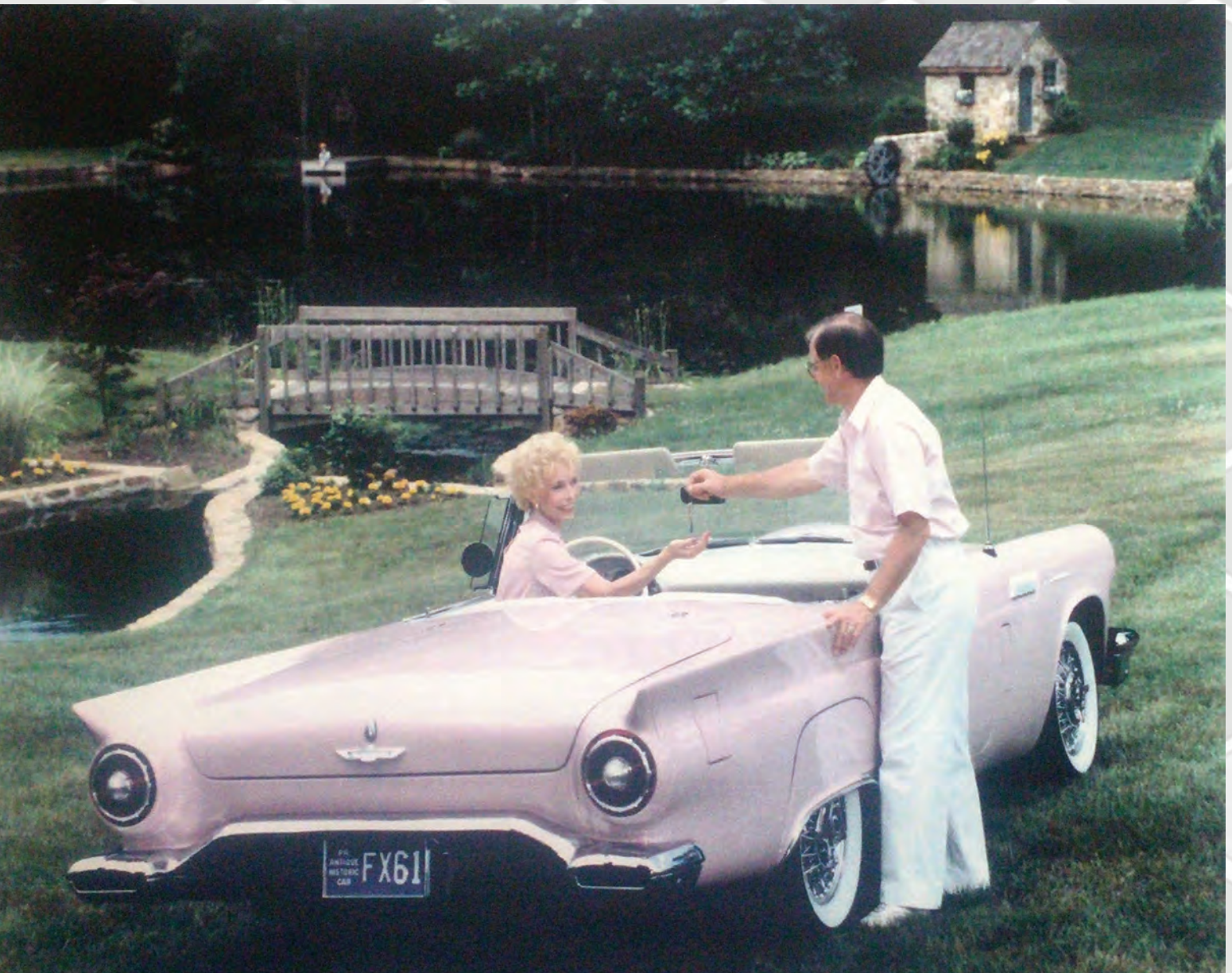

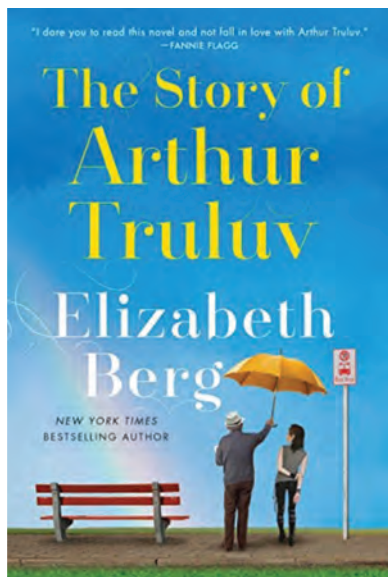

Investment Policy Legal Authority – Bylaws 8.2

I. Investment Subcommittee

A. PURPOSE/OBJECTIVE:

The Finance Committee has general oversight of the financial policies of the Sun City Summerlin Community Association, Inc (the “Association”) and makes recommendations to the Association's Board of Directors (“Board”) on the financial policies and the annual budget in order to assist the Board of Directors in executing their fiduciary responsibility to the members of this Association. The Investment Subcommittee was formed to provide investment policy oversight for the Finance Committee and to serve in a liaison capacity with the Association's contracted investment professionals who assist in the management of the Association's investment portfolio. Other duties determined by the Association Treasurer may be assigned.

B. SUBCOMMITTEE RESPONSIBILITIES AND PROCEDURES:

1. Make recommendations to the Finance Committee regarding investment guidelines, goals, objectives and limitations.
2. Work with the contracted investment professionals to insure approved investment criteria are being followed.
3. Meet at least quarterly and provide periodic reporting to the Finance Committee as to the progress of the investment portfolio towards the

plan objectives. This will include return on investment, liquidity and risk assessment.

4. Make recommendations regarding investment fees
5. Make other recommendations to the Finance Committee as appropriate.

C. INVESTMENT ADVISOR:

1. Actively monitor the investment portfolio with monthly reporting and detailed quarterly reviews.
2. Work with the Investment committee to coordinate reserve account maturities and liquidity requirements, as dictated by the most recent reserve study and Capital Acquisitions Requirement (CAR) forecast in the Annual Budget.
3. Act in an advisory capacity to the Board and Treasurer.
4. Recommend a specific asset allocation to the Investment Committee, Board and Treasurer.
5. Provide the Treasurer and the Board of Directors with an annual review addressing;
 - a. The investment forecast for the coming year.
 - b. The effect of that outlook on the attainment of the objectives.
 - c. Liquidity review to meet next year Capital Acquisition Request forecast.

II. Financial Management Policy

A. PURPOSE:

1. This policy governs the investment activities of the Association, with regard to the cash and other assets of the Association. The policy must comply with the requirements outlined in NRS 116, which is entitled the Uniform Common-Interest Ownership Act. This policy has been adopted by and can be changed only by the Board.
2. This policy is designed to ensure the prudent investment of the assets and to provide for the availability of funds when needed.
 - a. Notwithstanding any other provision of this policy, the Finance Committee shall recommend to the Board the appointment of an investment advisory firm or other similar organization to assume responsibility for investment decisions

of the funds. Upon approval by the Board of such recommendation, the Investment Management Agreement shall contain terms satisfactory to the Investment Advisor and the Association Board; and be consistent with the Investment Policy. Then, this Investment Agreement shall be submitted to the Board for its approval and execution.

- b. Participants in the investment process shall act responsibly as custodians of the funds. Investment officials shall recognize that the investment portfolio is subject to public review and evaluation. The overall investment program shall be designed and managed with a degree of professionalism that is worthy of the Association's trust.
 - c. Any practice not clearly authorized under these policies is prohibited. The guidance set forth herein is to be strictly followed by all those responsible and/or involved in any aspect of the management or administration of these funds.
3. The Executive Director of the Association shall have the direct responsibility for administering the policy, subject to the provision that the Executive Director shall also be permitted to delegate to any person, whether or not a member of the Association staff, such responsibility and authorization for execution of any instructions required to implement the policy. Participants in the investment process shall act responsibly as custodians of the assets as prescribed in NRS 116.3103 and NRS 116A.630.
 4. Any practice or investment not clearly authorized under the policy is prohibited. The guidance set forth herein is to be strictly followed by all those responsible for any aspect of the investment, management or administration of these funds.

B. INVESTMENT OBJECTIVES:

1. The assets shall be invested to accomplish the following hierarchy of objectives:
 - a. **Preservation of Principal**- The single most important objective is preserving the principal of the assets.
 - b. **Maintenance of Liquidity**- The assets shall be invested in such a manner that assures funds are available, as needed to meet the immediate and/or future operating requirements of the Association.

C. STANDARD OF PRUDENCE:

The standard of prudence to be applied to investment of the Association's assets shall be the industry standard "Prudent Investor Rule", which states: "Investments shall be made with judgment and care, under circumstances then prevailing which persons of prudence, discretion and intelligence exercise in the management of their own affairs, not for speculation, but for investment, considering the probable safety of their capital as well as the probable income to be derived."

D. AUTHORIZED INVESTMENTS:

The Association's assets may be invested in the following securities:

1. US Treasury Obligation. United State Treasury bills, notes, any other obligation or security issued by the United States Treasury or any other obligator guaranteed as to principal and interest by the United States.
2. Certificates of Deposits/Other Bank Deposits. Certificates of Deposits (CD's) or any other bank Deposit provided they are insured by the FDIC.

Deposit of Funds. In accordance with NRS 116.311395, NAC 116.405(8) (f) and the Declaration, and any amendments thereto, the Board shall cause all money of the Association to be deposited as follows:

- a. **Financial Institution.** The Financial institution in which the Association's funds are deposited ("**Qualified Financial Institution**") shall be one which is:
 - i. Located in the State of Nevada;
 - ii. Qualified to conduct business in Nevada; or
 - iii. Has consented in writing to be subject to the jurisdiction, including the power to subpoena, of the courts of Nevada and the Nevada Real Estate Division.

Should the Commission for the Common Interest Communities and Condominium Hotels (the "**Commission**") adopt a form for this purpose, the financial institution shall immediately complete the form upon request. Until that form is completed, the financial institution(s) at which the Association's money is deposited shall provide the Association with a short statement or other documentation demonstrating that it satisfies one of the foregoing requirements, and the Associa-

tion shall keep this documentation with all other documentation pertaining to the Association accounts at such financial institution(s).

- b. **Insured Accounts.** Consistent with the Association's governing documents and the options provided in NRS 116.311395(2), The Association's funds shall be deposited, maintained or invested in a Qualified Financial Institution whose accounts are insured by; (a) the Federal Deposit Insurance Corporation (the "FDIC"); (b) the National Credit Union Share Insurance Fund (the "NCUSIF"); (c) the Securities Investor Protection Corporation (the "SIPC"; (d) with a private insurer approved pursuant to NRS 672.755; or (e) in a government security backed by the full faith and credit of the Government of the United States.
1. **Amount of Deposits.** To protect the Association's financial assets, it is the Board's desire that the Association funds be deposited in a Qualified Financial Institution, insured at all times in accordance with NRS 116 and NAC 116 requirements. All funds of the Association shall be deposited into an account in a Qualified Financial Institution so as not to exceed the maximum amount that will be insured by that institution. By way of example, as of the date of this Investment Policy, such amounts are Two Hundred Fifty Thousand Dollars (\$250,000.00) per depositor (tax ID number), per insured bank, including principal and any accrued interest for accounts with FDIC or NCUSIF protection, (collectively, the "Insured Amount"). In the alternative, in the event the balance in the Association's account(s) exceed the maximum amount that will be insured by the FDIC, NCUSIF, or SIPC, then the Association shall retain excess coverage, such that the excess insurance provider shall cover any amounts that exceed the amounts covered by the FDIC, NCUSIF or SIPC ("Excess Coverage").

 - a. If necessary, the Association's funds may be deposited at different Qualified Financial Institutions to ensure that all funds of the Association are at all times within the limits of insurance coverage provided by the Qualified Financial Institution, FDIC, NCUSIF, SIPC or the Excess Coverage.
 - b. The Board may delegate such task to the Executive Director and the Treasurer shall cause the Association's accounts to be monitored on a monthly basis and shall arrange for any funds in excess of the Insured Amount to be

transferred to an account in a Qualified Financial Institution subject to the requirements of paragraph 4 below, where the Association's account balance is below the maximum insured limit.

- c. The Treasurer shall monitor any changes in the level of insurance at least annually.

Decision to Invest. No investment decision or decision to open a new account shall be made outside of a Board meeting, except as provided in NRS 82.271.

E. MAXIMUM MATURITY:

Maintenance of adequate liquidity to meet the cash flow needs of the Association is essential. Accordingly, Investments shall be structured in a manner that ensures sufficient cash is available to meet anticipated liquidity needs. Selection of investment maturities must be consistent with such requirements in order to avoid the forced sale of securities prior to maturity.

F. MONITORING AND ADJUSTING THE PORTFOLIO:

The investments Advisor will routinely monitor the funds of the portfolio, the available markets and the relative values of competing instruments and will adjust the portfolio as necessary to meet the investment objective list above. At least annually, the portfolio's maturities shall be scheduled against the reserve study for the following ten years.

G. SAFEKEEPING AND CUSTODY:

All securities in the Association's portfolio shall be held by the investment Advisor on behalf of the Association in accordance with NRS 116.311395 and will be free and clear of any lien. On a monthly basis, the depository will also provide reports and list all securities held, the book value of holdings and the market value as of month-end.

H. REPORTING

The Investment Advisory Firm will report to the Investment and Finance committee on a quarterly basis. At that time, the Investment Advisor will report on the portfolio's performance. The investment advisor will supply a summary report of the portfolio's holdings and transactions on a monthly basis.

- I. **AUTHORIZED SIGNERS ON ASSOCIATION ACCOUNTS.** Pursuant to Article VII, Section 7.2 and 7.5 of the Master Bylaws, the President and the Treasurer shall be authorized signers on the Association's accounts, provided that other officers may also be signers as the Board may require.
- J. **POWER TO WITHDRAW OR TRANSFER FUNDS.** Pursuant to NRS 116.31153, money in the Association's reserve accounts may only be withdrawn on the signature of two Board members or at least one Board member and one officer who is not a Board member. Funds from the Association's operating accounts may be withdrawn with two signatures, the first of which shall be either a Board member or one officer and the second of which shall be either a Board member or an officer. The Executive Director will not be a signor on any account maintained by the Association. Operating account funds may be withdrawn without signatures to:
- Transfer money to the Association's reserve account at regular intervals;
 - Make automatic payments for utilities;
 - Make an electronic transfer of money to a state agency in amounts of \$10,000 or more owned for taxes, interest, penalties or other obligations; or
 - Make an electronic transfer of money to the U.S. Government or its agencies which require electronic transfers.
- K. **ELECTRONIC SIGNATURES.** The Association may use electronic signature to withdraw operating account funds by taking the following steps:
- Agreement with Financial Institution.** The Board shall enter into a written agreement with the financial institution regarding the electronic transfer of money.
 - Express Authorization.** Pursuant to NRS 116.31153(4), the Board hereby expressly authorizes the electronic transfer of money which is defined as any transfer of money, other than a transaction initiated by a check or other similar instrument, that is initiated through an automated clearinghouse transaction, an electronic check transaction or a wire transfer for the purpose of ordering, instructing or authorizing a financial institution to debit or credit an account.
- c. **Internal Controls.** The Association shall establish internal accounting controls which comply with generally accepted accounting principles to safeguard Association assets.
- L. **FINANCIAL REVIEW BY THE BOARD.** As provided in NRS 116.31083 (6), the Board shall review, at a minimum, at a Board meeting held at least once each quarter, and not less than once every 100 days, the following financial information and document its review in the minutes of that meeting:
- A current year-to-date financial statement;
 - A current reconciliation of the reserve account and the operating account;
 - A current year-to-date schedule of revenues and expenses for the operating account and reserve account, compared to the budget for those accounts;
 - The latest account statements prepared by the financial institutions in which the accounts of the Association are maintained; and if the requirements of NRS 116.31083 (6), or any successor statute, are amended, the provisions of this Paragraph shall automatically be deemed to conform to such amendments and the Board shall review the financial information at such frequency as required under current Nevada Law.
- M. **RESERVE STUDY REVIEW ANNUALLY.** As required by NRS 116.31152, the Board shall annually review the Association's reserve study and incorporate its finding in the investment decision-making process to insure liquidity.
- N. **DIGITAL SIGNATURES.** If using digital signatures is allowed by current law, each director shall immediately upon signing into the financial institution for the first time, change his unique pass code so that only he or she can authorize the digital signature to be placed on the check or document.

COMPLAINTS REGARDING VIOLATIONS OF THE GOVERNING DOCUMENTS

SUN CITY SUMMERLIN COMMUNITY ASSOCIATION COMPLAINT AND HEARING PROTOCOL

FOR VIOLATIONS OF THE GOVERNING DOCUMENTS OF THE ASSOCIATION

Legal Authority – Bylaws 8.8 (c) NRS 116.31031

PREAMBLE

The purpose of the **Complaint and Hearing Protocol** is to establish a procedure for addressing in accordance with NRS 116.31031 both violations and hearings when violations of the Governing Documents are not timely cured by members or residents of the Association. Complaints against employees are not subject to this **Complaint and Hearing Protocol** and are handled by the Executive Director and Administration.

The Committees authorized to hold Hearings include:

1. **Hearing Committee (HC)**
- violations of architectural or property development standards.
2. **Clubs and Community Organizations Committee (CCOC)**
- violations of chartered clubs or community organizations procedures or rules.
3. **Legal Review Committee (LRC).**
-all other violations of the governing documents except for 4(a) and (b) below.
4. **The Board of Directors:**

The Board of Directors:

- a) Shall hear Age Restriction Violations. The Complainant shall be the office of the Executive Director on behalf of the Association.
- b) Shall hear all violations where sanctions, other than fines, may be imposed.
- c) At its discretion, may hear any complaint or delegate any complaint, with the exception of (a) or (b) above, to the HC, LRC or CCOC. A minimum of a quorum of members is required when the Board of Directors is the Hearing Panel.

I. INTRODUCTION

1. Complaints must be based on a violation or violations of one or more of the governing documents or statutes. Sufficiency of a violation is determined by review of the allegation(s) in conjunction with the governing documents and statutes. Once the sufficiency of a violation has been determined, the Association through the appropriate administrative department (hereinafter, "Complainant"), assigned by the Executive Director, will send, within **ten (10) business days** by mail, written notice of the violation to the homeowner and/or the person responsible (hereinafter "Respondent") for the alleged violation. The written notice must include:

- (a) Specific details of the alleged violation and the proposed action to cure the alleged violation.
- (b) An explanation of the applicable provisions of the governing documents that form the basis for the alleged violation.
- (c) A photograph of the alleged violation, if applicable.
- (d) A deadline for the alleged violation to be cured before the SCSCAI Board of Directors will take additional actions, including, without limitation fines and other sanctions available pursuant to NRS 116.31031 and the governing documents of SCSCAI.

Written notice will be mailed to the address of the unit and, if different, to a mailing address specified by the unit's owner.

2. If the violation is cured within the time period specified in the written notice, the file is closed, and the Complainant and Respondent are advised by letter accordingly.
3. If the alleged violation is not cured within the time period specified in the written notice, a second written notice will be sent by the Complainant by mail, to the Respondent including all of the following information.
 - (a) Details of the alleged violation, including the applicable provisions of the governing documents that form the basis for the alleged violation.
 - (b) Specific details as to the proposed action necessary to cure the violation within ten (10) business days from the date of the written notice. The Respondent may request an extension of

time to cure the deficiency. At the discretion of the Executive Director the ten (10) days may be extended for a reasonable period of time.

- (c) A photograph of the alleged violation, if applicable.
- (d) The right to contest the violation at a Hearing.
- (e) The amount of the fine and/or other sanctions that could include but not be limited to loss of voting right or suspension of privileges.
- (f) Date, time, and location of the Hearing.

Written notice will be mailed to the address of the unit and, if different, to a mailing address specified by the unit's owner.

If the violation is not cured within the time period specified in the written notice the Complaint will be referred to the LRC, CCOC or to the Board of Directors, by the Executive Director and the Hearing will take place on the date, time and at the location specified in the written notice. Prior to imposing a fine or other sanction a hearing must be held, unless the fine is paid before the hearing, or if the Respondent executes a written waiver of the right to a hearing.

4. When an owner or staff member (hereinafter, "Complainant") is aggrieved by an alleged violation by another owner or resident, they may, not later than 30 days after the alleged violation has occurred, file with the office of the Executive Director a written letter that sets forth the facts constituting the alleged violation. The letter sent to the Executive Director must include:

- (a) a summary of the alleged violation
- (b) all reasonable efforts taken to resolve the alleged violation
- (c) any other material or information that the Complainant believes is important to the investigation of the alleged violation
- (d) an agreement to testify, if necessary, at a Hearing
- (e) any other supporting documentation if applicable.

Upon receipt of the letter and supporting documentation, the Executive Director will review the Complaint to confirm that the actions complained of may represent an alleged violation of a section or sections of the governing documents or statute. Within five (5) business days the Executive Director shall reach out to the parties to determine if there is an interest in resolution without the benefit of a Hearing. If so, the parties will meet

individually with the Executive Director or their designee, and at the Executive Director's discretion an informal meeting can be arranged between the parties with the Executive Director facilitating discussion and possible resolution of the issue.

- (a) If the matter is resolved the file is closed with the Complainant and Respondent advised accordingly by letter.
- (b) If the matter is not resolved, the Executive Director will confirm sufficiency for the alleged violation. If sufficiency is confirmed the Complaint will be assigned to the appropriate administrative department (hereinafter, "Complainant"). The procedure as detailed under I. 1. will then be followed in the management of the Complaint. At the discretion of the Executive Director previously stated deadlines may be extended.

II. REFERRAL TO LRC, CCOC OR BOARD OF DIRECTORS FOR A HEARING

1. Within 1 (one) business day after the time has elapsed to cure the violation as provided in the written notice, described in I. 3 above, the appropriate administrative department shall provide the Respondent by mail with all supporting documentation that may include a list of the Complainant's witnesses and the Complainant's representative, if any, that will be present at the Hearing together with the Answer Form and a copy of the **Complaint and Hearing Protocol**. It is at the discretion of the Executive Director if the Complainant is provided with a copy of the information provided to the Respondent. The Respondent will also be advised at this time whether the HC, LRC, CCOC or Board of Directors will hear the Complaint; the name of the HC, LRC, CCOC or Board Hearing Committee Chairperson; and the members of the Committee appointed by the Chairperson of the Committee. designated to hear the complaint. No member of the Board of Directors is eligible to serve as a member of the HC, LRC or CCOC Hearing Committee.

2. The Respondent must file an Answer with the office of the Executive Director unless otherwise advised with all supporting documents, including a list of witnesses and the Respondent's representative, if any, within **seven (7) business days** from the date of the letter. A copy of the Respondent's Answer and any supporting documents including a list of witnesses and the Respondent's representative, if any, shall be sent to the Complainant, if other than the Executive Director, and to the Chairperson and members of the Committee of the Committee designated to hear the complaint or to the Board of Directors by the office of the Executive Director.

3. Either party may request in writing a *continuance* of the date assigned for the hearing. The first request will be granted. Any subsequent request for a *continuance* must be in writing and for good cause. The decision to grant the subsequent request for a *continuance* will be at the sole discretion of the Committee Chairperson of the Committee designated to hear the complaint in consultation with their Committee or the Board of Directors if the hearing is before the Board.

4. Each party may submit additional documents including a list of additional witnesses and a representative, if any, not less than seven (7) **business** days before the date of the scheduled hearing. Such additional documents shall be provided to the other party by the office of the Executive Director. Any additional documents received less than seven (7) **business** days before the meeting date set for the Hearing may be admitted at the discretion of the Committee Chairperson of the Committee designated to hear the complaint in consultation with their Committee or the Board of Directors if the hearing is before the Board.

5. A hearing must proceed prior to a fine being imposed or sanctions recommended to the Board of Directors, unless the fine is paid by the Respondent before the hearing; the Respondent executes a written waiver of the right to a hearing; or the Respondent fails to appear for the hearing. In these circumstances the decision of Committee designated to hear the complaint will be determined based on the written record. If the Respondent fails to file an Answer within the seven (7) business days permitted and does not ask for a continuance, the hearing will still proceed as scheduled.

III. HEARING PROCEDURE

1. Executive Session: Unless an open Hearing is specifically requested on the Answer Form by the Respondent, the Hearing shall be held in Executive Session. All deliberations and voting of the HC, LRC, CCOC or the Board of Directors shall be held in Executive Session.

2. Witnesses: No witness for either party shall be permitted to attend the Hearing until they have completed their testimony and been dismissed by the Hearing Chairperson.

3. Representation: A party may be represented and/or assisted by any other person, including legal counsel. The name of such person or legal counsel to be provided on the Answer Form.

4. Recusal: Members of the HC, LRC, CCOC or the Board may voluntarily recuse themselves at any time without explanation. No later than five (5) **business** days prior to the hearing date either party may request in writing that one or more HC, LRC, CCOC members or members of the Board be recused giving the reasons for the request. The

challenged member may consent or refuse recusal. If the request for recusal is refused by the challenged member, the remaining members of the HC, LRC, CCOC or Board of Directors shall discuss and vote in executive session whether or not to remove the challenged member. A majority or tie vote of the HC, LRC, CCOC or Board of Directors shall approve participation in the Hearing by the challenged member.

5. Case Presentation: The Complainant and Respondent shall each have thirty (30) minutes to present their respective cases, including the oral testimony of all witnesses. If the Complainant is SCSCAI, the aggrieved party that initiated the Complaint will testify, if necessary, for the Complainant. Upon request of either party, the HC, LRC, CCOC or Board of Directors, in their discretion, may, for good cause, grant an extension of time for case presentation and/or rebuttal with such extension also being granted to the other party.

6. Rebuttal and Cross-examination: At the conclusion of the presentation of the respective cases by the parties, each party will have fifteen (15) minutes to rebut and/or question the other party and witnesses.

7. HC, LRC, CCOC or Board of Director Questioning: The HC, LRC or CCOC or Board of Directors, if the hearing is before the Board of Directors, may question the parties and the witnesses during or at the end of each case presentation and rebuttal. Time for such questioning will not be deducted from the party's allotted time.

8. Deliberations and the Decision of HC, LRC, CCOC and/or Board of Directors: At the conclusion of the Hearing, the HC, LRC or CCOC or Board of Directors shall recess to Executive Session for deliberation and voting. A written report of the decision shall be made part of the case file including the rationale for the decision, the number of votes for and against the decision, any fine assessed, and whether the matter was referred to the Board for an hearing for additional sanctions. Any dissenting report shall also be made part of the case file. The reports from the Hearing from the HC, LRC and/or CCOC shall be presented to the Board of Directors in Executive Session for its information at the next regularly scheduled Board meeting and sent regular mail by the Executive Director to all parties involved.

9. Continuing Violation: If a fine is imposed at the Hearing and the violation is not cured within 14 days, or any longer period of time granted by the HC, LRC, CCOC or the Board of Directors, the violation, as defined by NRS 116.31031, 7, will be deemed to be a continuing violation. The Board of Directors in Executive Session or by written consent can then impose a fine for every seven-day period or a portion thereof until the violation is cured.

SECTION 2

COMPLAINTS REGARDING VIOLATIONS OF THE DEVELOPMENT STANDARDS (Property Violations)

(f) Date, time, and location of the Hearing.

Written notice will be mailed to the address of the unit and, if different, to a mailing address specified by the unit's owner.

I. INTRODUCTION

1. Once the sufficiency of a violation has been determined by the Association through the office of Community Standards (hereinafter, "Complainant"), they will send within **ten (10) business days** written notice to cure the alleged violation to the unit's owner or person responsible (hereinafter, "Respondent") for curing the alleged violation. The written notice must include:

- (a) An explanation of the applicable provisions of the governing documents that form the basis of the alleged violation.
- (b) Specific details of the alleged violation and the proposed action to cure the alleged violation.
- (c) A photograph of the alleged violation, if applicable.
- (d) The deadline for the alleged violation to be cured before the SCSCAI Board of Directors will take additional actions, including, without limitation fines and other sanctions available pursuant to NRS 116.31031 and the governing documents of SCSCAI.

2. If the violation is cured within the time period specified in the written notice, the file is closed, and the Respondent is advised by letter accordingly.

3. If the alleged violation is not cured within the time specified in the written notice, a second written notice will be sent by mail from the Complainant to the Respondent. The second written notice must include:

- (a) Details of the alleged violation, including the applicable provisions of the governing documents that form the basis of the alleged violation.
- (b) Specific detail as to the proposed action necessary to cure the violation within a reasonable time provided in the written notice.
- (c) A photograph of the alleged violation, if applicable.
- (d) The right to contest the violation at a Hearing.
- (e) The amount of the fine and/or other sanctions that could include but not be limited to loss of voting right or suspension of privileges.

4. If the violation is not cured within the time period specified in the written notice the Complainant will refer the violation to the Hearing Committee (hereinafter "HC") and the Hearing will take place on the date, time and at the location specified in the second written notice.

II. Referral to the Hearing Committee

1. Within 1 (one) business day after the time has elapsed to cure the violation as provided in the written notice, described in I. 3 above, HC shall provide the Respondent by mail with all supporting documentation, which may include, a list of the Complainant's witnesses and the Complainant's representative, if any, that will be present at the Hearing together with the Answer Form and a copy of the **Complaint and Hearing Protocol**. The Respondent will also be advised at this time of the members of HC who will comprise the hearing committee. No member of the Board of Directors is eligible to serve as a member of HC.

2. The Respondent must file an Answer with the Community Standards office unless otherwise advised with all supporting documents, including a list of witnesses and the Respondent's representative, if any, within **seven (7) business days** from the date of receipt of the letter. A copy of the Respondent's Answer and any supporting documentation will then be provided to members of HC.

3. Either party may request in writing a *continuance* of the date assigned for the hearing. The first request will be granted. Any subsequent request for a *continuance* must be in writing and for good cause. The decision to grant the subsequent request for a *continuance* will be at the sole discretion of HC Hearing Officer in consultation with the Hearing Committee.

4. Each party may submit additional documents including a list of additional witnesses and a representative, if any, not less than seven (7) **business** days before the date of the scheduled hearing. Such additional documents shall be provided to the other party by Community Standards. Any additional documents received less than seven (7) **business** days before the meeting date set for the Hearing may be admitted at the discretion of the HC Hearing Officer in consultation with the Hearing Committee.

5. A hearing before HC must proceed prior to a fine being imposed or sanctions recommended to the Board of Directors, unless the fine is paid by the Respondent before the hearing; the Respondent executes a written waiver of the right to a hearing; or the Respondent fails to appear for

the hearing. In these circumstances the decision of HC will be determined based on the written record. If the Respondent fails to file an Answer within the seven (7) business days permitted and does not ask for a continuance, the hearing will still proceed as scheduled.

III HEARING PROCEDURE

1. Executive Session: Unless an open hearing is specifically requested on the Answer Form by the Respondent, the hearing shall be held in Executive Session. All deliberations and voting of HC shall be held in Executive Session.

2. Witnesses: No witness for either party shall be permitted to attend the Hearing until they have completed their testimony and been dismissed by Chairperson for HC.

3. Representation: Respondent may be represented and/or assisted by any other person, including legal counsel. The name of such person or legal counsel to be provided on the Answer Form.

4. Recusal: Members of the HC may voluntarily recuse themselves at any time without explanation. No later than five (5) calendar days prior to the hearing date either party may request in writing that one or more members of HC be recused giving the reasons for the request. The challenged member may consent or refuse to do so. If the request for recusal is refused by the challenged member, the remaining members of HC shall discuss and vote in executive session whether or not to remove the challenged member. A tie vote shall approve participation of the challenged member at the hearing.

5. Case Presentation: The parties shall each have thirty (30) minutes to present their respective cases, including the oral testimony of witnesses. Upon request by a party, HC, in its discretion, may for good cause, grant an extension of time for case presentation and/or rebuttal with such extension also being granted to the other party.

6. Rebuttal and Cross-examination: At the conclusion of the presentation of the respective cases by the parties, each party will have fifteen (15) minutes to rebut and/or question the other party and witnesses.

7. HC questioning: HC may question the parties and the witnesses during or at the end of each case presentation and rebuttal. Time for such questioning by members of HC will not be deducted from the party's allotted time.

8. Deliberations and Decision of HC: At the conclusion of the hearing, HC shall recess to Executive Session for deliberation and voting. A written report of the decision shall be made part of the case file including the rationale for the decision, the number of votes for and against the

decision, any fine assessed, and whether the matter was referred to the Board for an hearing for additional sanctions. Any dissenting report shall also be made part of the case file. These reports shall be presented to the Board of Directors in Executive Session for its information at the next regularly scheduled Board meeting and sent by regular mail by the Executive Director to all parties.

9. Continuing Violation: If a fine is imposed at the Hearing and the violation is not cured within 14 days, or any longer period of time granted by the Hearing Committee the violation, as defined by NRS 116.31031, 7, will be deemed to be a continuing violation. The Board of Directors in Executive Session or by written consent can then impose a fine for every seven-day period or a portion thereof until the violation is cured.

SECTION 3:

APPEALS TO THE BOARD OF DIRECTORS from HC, LRC or CCOC

1. After Executive Director has notified the parties in writing of the decision of the HC, LRC, or CCOC, any party shall have ***ten (10) business days from the date of notification to file an Appeal to the Board of Directors*** in writing through the office of the Executive Director specifying the grounds for Appeal.

2. After receiving the Appeal, the Executive Director shall deliver the Appeal to the Board of Directors before its next regularly scheduled meeting at which time the Board of Directors shall determine whether to hear the Appeal. If the Board of Directors determines there is a failure to state sufficient grounds on which the Appeal is filed, a Notice of Insufficiency specifying the nature of the insufficiency shall be sent by regular mail to the appealing party at the address on file. The appealing party shall have ten (10) calendar days after receiving the Notice of Insufficiency to file one (1) amended Appeal curing the insufficiencies. Failure to do so shall result in dismissal of the Appeal. If the Board of Directors determines to hear the Appeal, it shall set a time and date for the hearing. The hearing may be held at the next regularly scheduled Board of Directors meeting or at any other time at the Board's discretion, but not sooner than fifteen (15) calendar days after the determination nor later than the next regularly scheduled Board of Directors meeting following the one after the determination. The appeal hearing will take place during executive session unless the appealing party requests an open hearing.

3. When the Board of Directors has set the time and date to hear the Appeal, the Executive Director shall so notify all

parties by mail within ten (10) business days and shall include with this notice the Appeal documents submitted by the appealing party. The non-appealing party shall then have fifteen (15) **calendar** days to submit a reply in writing, if desired, to the Executive Director who shall deliver it to the Board of Directors and shall promptly mail such reply to the appealing party.

4. Once an Appeal has been filed with the Executive Director, any fine imposed by the HC, LRC or CCOC which does not involve health and safety, shall be stayed pending the outcome of the appeal.

5. At the Appeal hearing the Board of Directors shall hear and consider only the submitted grounds for the appeal based on the HC, LRC or CCOC records both written or otherwise recorded. Appeals from decisions regarding violations of architectural or property development standards can only pertain to the amount of the fine. Any appeal from the decision by HC, LRC or CCOC of all other violations can be on the sufficiency of the violation and for any fine imposed because of the alleged violation. Oral argument by the parties on appeal shall be limited to ten (10) minutes each.

6. The Board of Directors may uphold the decision of the HC, LRC or CCOC, reverse the decision, or modify the decision as it sees fit or grant a new hearing before the Board of Directors as the new HC, LRC or CCOC. The Executive Director shall notify all parties of the Board of Directors' decision in writing by regular mail.

7. The decision of the Board of Directors is FINAL and represents the decision of the Association.

SECTION 4:

COMPLAINTS BY UNIT OWNERS AGAINST THE BOARD OF DIRECTORS REGARDING ALLEGED LAW AND/OR GOVERNING DOCUMENT VIOLATIONS

NRS 116.31087 provides the following to address a written complaint from a unit owner alleging that the executive board or any member thereof (hereinafter, the "Board") has violated any provision of NRS 116 or any provision of the governing documents.

Right of units' owners to have certain complaints placed on agenda of meeting of executive board.

1. If an executive board receives a written complaint from a unit's owner alleging that the executive board has violated any provision of this chapter or any provision of the governing documents of the association, the executive

board shall, upon the written request of the unit's owner, place the subject of the complaint on the agenda of the next regularly scheduled meeting of the executive board.

2. Not later than 10 business days after the date that the association receives such a complaint, the executive board or an authorized representative of the association shall acknowledge the receipt of the complaint and notify the unit's owner that, if the unit's owner submits a written request that the subject of the complaint be placed on the agenda of the next regularly scheduled meeting of the executive board, the subject of the complaint will be placed on the agenda of the next regularly scheduled meeting of the executive board.

A unit owner who believes that the Board has violated any provision of NRS116 or of the governing documents shall submit a written complaint to the Executive Director by mail or by presenting it at the Administrative Offices at Mountain Shadows.

The complaint should clearly state what section of NRS 116 or of the governing documents has allegedly been violated. If the unit owner is not able to specify a specific section of the law or of the governing documents, the letter should state as clearly as possible what violation is alleged.
